- 9 NECESSITY, FUNCTION, AND CONFORMITY: KRS 321.175(4) states the purpose of the
- 10 Kentucky Veterinary Medicine Practice Act is to promote, preserve, and protect the public health,
- safety, and welfare by and through, in part, the registration and regulation of veterinary facilities
- and mobile facilities where and from which the practice of veterinary medicine occurs. KRS
- 13 321.236(1)(a) authorizes[allows] the Kentucky Board of Veterinary Examiners to promulgate
- administrative regulations defining the application requirements and fees for veterinary facilities.
- 15 KRS 321.235(1)(b) requires the Kentucky Board of Veterinary Examiners to promulgate
- administrative regulations to effectively carry out and enforce the provisions of KRS Chapter 321.
- 17 This administrative regulation establishes application requirements for veterinary facilities.
- 18 Section 1. Definitions.
- 19 (1) "Fixed facility" is defined by [has the same meaning as] KRS 321.181(38).
- 20 (2) "Mobile facility" or "mobile unit" is defined by [has the same meaning as] KRS 321.181(46).
- 21 [A veterinary facility mobile unit shall be primarily used for the practice of veterinary

1 medicine or the practice of veterinary technology.]

- 2 (3) "Practice of veterinary medicine" is defined by KRS 321.181(50).
- 3 (4) "Practice of veterinary technology" is defined by KRS 321.181(51).
- 4 (5) "Premises" is defined by KRS 321.181(52).
- 5 (6) "Registered responsible party" is defined by KRS 321.181(57).
- 6 (7) "Veterinarian manager" is defined by KRS 321.181(68).
- 7 (8) "Veterinary facility" is defined by KRS 321.181(71).
- 8 Section 2. General Requirements. Each veterinary facility that is located in Kentucky where the
- 9 practice of veterinary medicine or practice of veterinary technology occurs shall possess a
- veterinary facility registration issued by the Kentucky Board of Veterinary Examiners. Pursuant
- to KRS 321.236(2), all existing veterinary facilities in Kentucky shall be registered by June 30,
- 12 2025.
- 13 (1) A veterinary facility registration shall not be issued without a physical facility, either a fixed
- 14 facility or mobile unit.
- 15 (2) A veterinary facility shall be a dedicated space equipped for, staffed, and primarily devoted to
- the practice of veterinary medicine or the practice of veterinary technology.
- 17 (3) A mobile facility shall be registered as an affiliate unit on a fixed facility registration, or
- independently under a unique veterinary facility registration with a designated physical location
- 19 for parking and storage.
- 20 (4) A registered facility shall have no more than two (2) mobile units under its registration without
- 21 incurring additional registration and renewal fees as established in 201 KAR 16:515.
- 22 (5) A registered veterinary facility shall prominently display the current registration certificate in
- a public area of the registered facility. The registration certificate shall:

- 1 (a) **Be legible**[**Legible**]; and
- 2 (b) Show the current dates of registration.
- 3 Section 3. Exemptions from Requirements for Veterinary Facility Registration.
- 4 (1) The following premises shall be exempt from the requirements of this administrative
- 5 regulation:
- 6 (a)[(1)] Premises identified in KRS 321.181(71)(b):[-]
- 7 (b)(2) An expert who provides consulting services only to other veterinarians, who does not
- 8 engage in the practice of veterinary medicine on a patient directly, and who does not have a
- 9 physical facility, either fixed or mobile, where the consultant practices on animal patients:[-]
- 10 (c)[(3)] Public rabies <u>vaccine-only</u>[vaccine] clinics held in accordance with KRS 258.043; and[-]
- 11 (d) Government sponsored vaccine clinics for animals solely to prevent infectious disease
- and that do not include diagnostics, surgery, or the dispensation of prescription
- 13 medications.
- 14 (2) The exception to register a premises as a veterinary facility as identified in subsection
- 15 (1)(c) and (d) of this section does not alleviate a veterinarian from creating and maintaining
- medical records in accordance with 201 KAR 16:701.
- 17 [(a) The local health department or veterinarian providing services under KRS 258.043
- 18 shall register the rabies clinic with the board at least 30-days in advance of the event by
- 19 submitting a completed application on an Registration for Mass Rabies Immunization
- 20 Clinic form or online equivalent form, including all required attachments.
- 21 (b) If other services are rendered, including the administration of other vaccines or
- 22 veterinary products are sold, then the veterinarian must practice at a registered veterinary
- 23 facility, either fixed or mobile, and a medical exam shall be provided to each patient and a

1 complete medical record shall be established in accordance with 201 KAR 16:701.]

- 2 Section 4. Registered Responsible Party.
- 3 (1) Each application for a veterinary facility registration shall name the facility and identify each
- 4 registered responsible party.
- 5 (2) Pursuant to KRS 321.236(5), each registered responsible party shall be accountable for
- 6 ensuring the requirements of KRS Chapter 321 and 201 KAR Chapter 16 are met, including the
- 7 timely designation of a veterinarian manager for the veterinary facility in accordance with the
- 8 provisions of 201 KAR 16:767.
- 9 (3) If[When] When it is determined that a registered responsible party has violated any provisions
- of the Kentucky Veterinary Medicine Practice Act or 201 KAR Chapter 16, the board may take
- disciplinary action equal to that for a licensed veterinarian as provided by the Kentucky Veterinary
- 12 Medicine Practice Act.
- 13 Section 5. Veterinarian Manager.
- 14 (1) Each application for a veterinary facility registration shall designate a veterinarian manager.
- 15 The application shall include the veterinarian manager's original signature, or, if completed online,
- an equivalent digital signature.
- 17 (2) A veterinarian manager shall be responsible for meeting the requirements of KRS Chapter 321
- and 201 KAR Chapter 16, including ensuring the requirements for minimum standards are met
- 19 and maintained.
- 20 Section 6. New Application Requirements. A new application to the board for registration as a
- veterinary facility shall include the following components:
- 22 (1) A completed application on an Application for Veterinary Facility Registration form or online
- equivalent form, including all required attachments and fees pursuant to 201 KAR 16:515;

- 1 (2) A complete list of persons or entities who shall be the registered responsible party;
- 2 (3) Identification of the veterinarian manager;
- 3 (4) Identification of the name, phone, address, and email address of the registered facility;
- 4 (5) A copy of the Secretary of State business registration [from the Kentucky Secretary of
- 5 State];
- 6 (6) Identification of the species served from one (1) or more in a list provided by the board;
- 7 (7) Identification of the patient services offered at the veterinary facility from one (1) or more in a
- 8 list provided by the board;
- 9 (8) A complete list of veterinarians working at the facility, excluding veterinarians providing
- 10 locum services less than fourteen (14) days in a calendar year to the facility;
- 11 (9) A complete list of licensed veterinary technicians working at the facility;
- 12 (10) A complete list of allied animal health professional (AAHP) permittees working at the facility;
- 13 (11) A complete list of mobile units affiliated with the veterinary facility;
- 14 (12) Disclosure of after-hours care arrangements;
- 15 (13) For fixed facilities, county of facility location and counties served;
- 16 (14) If the facility offers a haul-in installation **for livestock**;
- 17 (15) For mobile units, a list of the counties served by the mobile unit;
- 18 (16) Hours of operation;
- 19 (17) A copy of any court documents, final orders, settlement agreements, or other documents
- 20 requested by the board in support of the application; and
- 21 (18) Any other information requested by the board in support of the application.
- Section 7. Background Checks. Pursuant to KRS 321.189, the board may:
- 23 (1) Conduct a national or jurisdictional level background check on each veterinarian manager

- applicant for registration. The check shall be processed by a board approved background check
- 2 provider and may include a copy of the applicant's fingerprints captured at a board-approved
- 3 location;
- 4 (2) Reject background checks that do not have an official seal or watermark, or that are more than
- 5 ninety (90) days old:[-]
- 6 (3) Impose additional requirements as a condition of registration or deny registration following the
- 7 board's review of findings from a background check; and
- 8 (4) Waive the background check requirement for a veterinarian manager who is already licensed
- 9 in Kentucky and if[when] a background check was previously conducted as a condition of
- 10 licensure.
- 11 Section 8. Renewal and Reinstatement of Veterinary Facility Registrations. Pursuant to 201 KAR
- 12 16:765, a registered responsible party or veterinarian manager shall:
- 13 (1) Ensure the timely renewal of the veterinary facility registration; and
- 14 (2) If applicable, ensure an appropriate reinstatement application is made to the board.
- 15 Section 9. The veterinary facility registration certificate shall be posted in a publicly viewable area
- on the facility premises or on the mobile unit.
- 17 Section 10. Incorporation by Reference.
- 18 (1) [The following material is incorporated by reference:

This new administrative regulation is necessary to establishes requirements approved by the board

for veterinary facility registration applications.

(c) How this administrative regulation conforms to the content of the authorizing statutes:

KRS 321.175(4) states the purpose of the Kentucky Veterinary Medicine Practice Act is to

promote, preserve, and protect the public health, safety, and welfare by and through, in part, the

registration and regulation of veterinary facilities and mobile facilities where and from which the

practice of veterinary medicine occurs. KRS 321.236(1)(a) allows the Kentucky Board of

Veterinary Examiners to promulgate administrative regulations defining the application

requirements and fees for veterinary facilities. KRS 321.235(1)(b) requires the agency to

promulgate administrative regulations to effectively carry out and enforce the provisions of KRS

Chapter 321.

This new administrative regulation will assist in effective administration by clearly expressing the

application requirements approved by the board for veterinary facility registration applicants.

The KBVE expects costs for all board operations to be approximately \$759,700 annually in the near term.

The KBVE expects costs for all board operations to be approximately \$900,000 annually in future bienniums as new programming is brought online, per the mandates in the modernized Kentucky Veterinary Medicine Practice Act, KRS Chapter 321.

(6) What is the source of the funding to be used for the implementation and enforcement of this administrative regulation:

KBVE does not receive any general funds. All funds for the agency come from licensing fees, service fees, and administrative fines.

(7) Provide an assessment of whether an increase in fees or funding will be necessary to implement this administrative regulation, if new, or by the change if it is an amendment:

There is no anticipation of an increase in fees to implement this administrative regulation, as the KBVE is already running an administrative program to process applications and an enforcement program to ensure compliance.

This regulation does not establish or increase any fees, directly or indirectly.

IV. Summary of Comments and Responses

- (1) Subject Matter: Local Health Departments (LHDs) named in regulation
- (a) Comment: Ms. Brooks, Dr. Giesbrecht The commentors state that KBVE does not have the authority to require LHDs to conform to these requirements. The commentor recommends removal of the words "local health department" in Section 3(3)(a), from the registration form, and the requirement that the LHD complete the form on behalf of another entity (in this case, the veterinarian).
- (b) Response: After learning of these concerns, KBVE had multiple conversations with staff at the Cabinet for Health and Family Services (CHFS). Given the concerns for public health related to this zoonotic disease as well as the frequency with which rabies clinics are held, KBVE determined that reporting as outlined in the original filing would not be appropriate. KBVE fully supports the protection of public health and did not intend to establish any barriers related to these public health offerings. In response to these and similar comments, KBVE removed any reporting requirements upon LHDs, and determined that the registration form would not be required.
 - (2) Subject Matter: Barriers to protection of public health
- (a) Comment: Ms. Brakefield, Ms. Brooks, Dr. Giesbrecht, Mr. Mathis The commentors state that the proposed requirements to register rabies clinics under KRS 258.043 are barriers to the protection of public health due to increased administrative burden. The sole goal of the mass rabies clinics is to provide the rabies vaccine to as many animals as possible, and any increased administrative burden will be a barrier to public health.
- (b) Response: Following multiple conversations with CHFS staff and given the concerns for public health related to this zoonotic disease as well as the frequency with which rabies clinics are held, KBVE determined that reporting as outlined in the original filing would not be appropriate. KBVE fully supports the protection of public health and did not intend to establish any barriers related to these public health offerings. In response to these and similar comments, KBVE removed any reporting requirements upon LHDs, and determined that the registration form would not be required.

- (3) Subject Matter: Requirements for advance approval of rabies clinics held under KRS 258.043 will lead to decreased rabies clinic offerings
- (a) Comment: Ms. Brakefield, Ms. Brooks, Mr. Foley, Mr. Mathis The commentors state the increased administrative burdens and timelines for approval will cause county entities, LHDs, and other providers to discontinue this vital public service. One commentor stated that if KBVE wishes to implement this rule, they should also plan to host their own regional mass clinics to backfill for the loss of LHD sponsored clinics.
- (b) Response: Following multiple conversations with CHFS staff and given the concerns for public health related to this zoonotic disease as well as the frequency with which rabies clinics are held, KBVE determined that reporting as outlined in the original filing would not be appropriate. KBVE fully supports the protection of public health and did not intend to establish any barriers related to these public health offerings. In response to these and similar comments, KBVE removed any reporting requirements upon LHDs, and determined that the registration form would not be required.
 - (4) Subject Matter: Requirement to list veterinarians providing services
- (a) Comment: Mr. Foley The commentor states that their animal control agency uses staff veterinarians during the clinic offerings, sometimes as many offerings as 2-3 per month. Other times, licensed veterinarians may volunteer to participate. The commentor asks, if this form is implemented, and there is a last minute change in the veterinarian who is listed on the form, what happens?
- (b) Response: In response to other comments, KBVE discontinued the requirement for the use of a registration form, so this question is no longer applicable.
 - (5) Subject Matter: Timelines for approval of mass rabies clinic offerings
- (a) Comment: Mr. Foley, Dr. Giesbrecht The commentors expressed concerns that this form approval process may unduly delay offerings of public mass rabies clinics. They stated that if a form ends up being required, they hope that a process was established to ensure approvals were issued as fast as possible so as not to delay the ability to hold a mass rabies clinic.
- (b) Response: Following multiple conversations with CHFS staff and given the concerns for public health related to this zoonotic disease as well as the frequency with which rabies clinics are held, KBVE determined that reporting as outlined in the original filing would not be appropriate. KBVE fully supports the protection of public health and did not intend to establish any barriers related to these public health offerings. In response to these and similar comments, KBVE removed any reporting requirements upon LHDs, and determined that the registration form would not be required.

- (6) Subject Matter: Limitations on offering additional veterinary services at a public rabies vaccine clinic, if the clinic is not at a registered veterinary facility / objections to map requirement on form
- (a) Comment: Dr. Grimes, Dr. Giesbrecht The commentors expressed opposition to the map requirements attached to the registration form. One commentor described detailed procedures used at prior veterinary clinics offered to the public, some of which did not occur at a registered veterinary facility and many of which offered services other than rabies vaccines under KRS 258.043. One commentor interpreted the Rabies Clinic Registration form as requiring traffic cones and requiring additional staff, and expressed concern about this perceived additional requirement which would be a financial burden to the public health offerings.
- (b) Response: With the exception of rabies vaccine clinics offered under KRS 258.043, and those exemptions as established in KRS 321.181(71), the Practice Act declares that practice of veterinary medicine, including wellness exams and the administration of vaccines other than rabies vaccines, shall occur at a registered veterinary facility and medical records shall be required pursuant to KRS 321.203, 321.236, and 321.187. In response to these and similar comments, KBVE removed any reporting requirements upon LHDs, and determined that the registration form would not be required.

However, following discussions with CHFS and Louisville Metro staff, the Board acknowledged their concerns about offerings related to public health and animal wellness. Consequently, the Board added an exemption for government sponsored vaccine clinics for animals offering vaccines solely to prevent infectious disease. The Board determined that this exemption does not allow other veterinary services (i.e., diagnostics, surgery, or the dispensation of prescription medications) to be offered at an unregistered location. The Board maintains that other veterinary services offered to the public shall occur at a registered veterinary facility, either fixed or mobile, in accordance with KRS Chapter 321 statutes. In response to this comment, an exemption was added to Section 3(1).

- (7) Subject Matter: Requirements for non-LHDs to hold mass rabies clinics
- (a) Comment: Mr. Foley, Dr. Giesbrecht The commentors ask, if this form is implemented, do other entities still need to complete this form? One commentor highlights that the Metro Government is not an LHD. They also state that Louisville Metro Department of Public Health and Wellness can host as many as 2-3 rabies clinics per month and those are sometimes sponsored by Metro Council Members and other non-LHD entities. The commentor asks, if this form is implemented, would Louisville Metro Animal Services or the Louisville Metro Department of Public Health and Wellness even need to complete the form since they are not an LHD?
- (b) Response: KBVE notes that the original intent of this form was a form of education related to the requirements that veterinary services only be offered at registered veterinary

facilities. This was in large part to prevent the offering of veterinary services at temporary locations where no post-care services are provided to clients and patients, particularly in times of emergency need for the patient. Following discussions, Members of the Board feel that education and outreach about the requirements may be handled through other means rather than requiring a registration form for these types of events. KBVE fully supports the protection of public health and did not intend to establish any barriers related to these public health offerings. Consequently, the Board added an exemption for government sponsored vaccine clinics for animals offering vaccines solely to prevent infectious disease. The Board determined that this exemption does not allow other veterinary services (i.e., diagnostics, surgery, or the dispensation of prescription medications) to be offered at an unregistered location. The Board maintains that other veterinary services offered to the public shall occur at a registered veterinary facility, either fixed or mobile, in accordance with KRS Chapter 321 statutes. In response to this comment, an exemption was added to Section 3(1).

- (8) Subject Matter: Concerns regarding corporate offerings at non-registered retail locations where there is no option for follow-up care
- (a) Comment: Dr. Grimes The commentor asks for clarification from the Board regarding the requirements for premises such as Tractor Supply that offer public veterinary clinics with wellness services. Will this still be allowed under the new rules? Does the traveling veterinarian have to do a complete physical exam and establish a VCPR? Who is required to keep the medical records in these situations? Or will these clinics no longer be permitted?
- (b) Response: Retail stores wishing to offer veterinary services must register all or part of their location as a veterinary facility and include appropriate medical equipment on site to support the services offered at those facilities. Additionally, each registered location in a retail environment must still have registered responsible parties and designate a veterinarian manager, pursuant to KRS 321.203 and 321.236. Medical records are the responsibility of the veterinarian providing services pursuant to KRS 321.187 and must be kept for a period of five years. For all services, a complete physical exam is required to establish the Veterinary-Client-Patient Relationship (VCPR) and patient health and fitness for the services to be provided. In response to these comments, the Board did not make any changes to the proposed administrative regulation
 - (9) Subject Matter: More data needed on state animal shelters
- (a) Comment: Dr. Grimes The commentor states that they are interested in seeing more data on the state animal shelters after facility registrations are in place.
- (b) Response: It is not within the Board's scope of authority to govern all animal shelters in the Commonwealth. While there are some minimal standards promulgated for animal shelters in KRS 258.119(3), this chapter is outside of KBVE's governing statutes (KRS Chapter 321). Animal shelters shall only need to register as a veterinary facility if they offer veterinary services

to the public for animals owned by the public. Transfer of ownership may not be used to circumvent this requirement. In response to these comments, the Board did not make any changes to the proposed administrative regulation.

- (10) Subject Matter: Conformity with KRS Chapter 13A
- (a) Comment: Agency Following legal review, the agency notes changes are necessary to conform with KRS Chapter 13A.
- (b) Response: In response to this comment, the Board made edits to the regulation for clarity of intent and conformity with KRS Chapter 13A.
 - (11) Subject Matter: Appreciation for the work of KBVE and its staff
- (a) Comment: Dr. J. Beckman The commentor thanks KBVE and the Members of the General Assembly for taking the time to hear and respond to concerns as outlined in their written letter to the board.
- (b) Response: Members of the Board are grateful for every comment that is received during the administrative regulations process, allowing the Board to offer explanations and justification for the proposed changes, including the opportunity to appropriately adjust changes when warranted. Members appreciate the acknowledgment for the agency and its staff, who often go unrecognized by the licensee population for their dedicated civil service to the public and the assistance they offer licensees daily. In response to these comments, the Board did not make any changes to the proposed administrative regulation.

V. Summary of Statement of Consideration and Action Taken by Promulgating Administrative Body

The public hearing on 201 KAR 016:762 was held per request; however, no one appeared at the hearing. Written comments were received during the public comment period. The Kentucky Board of Veterinary Examiners responded to the comment as noted above and amends the administrative regulation as follows:
