## New Graduate Licensure Program Consent and Contractual Agreement

The Kentucky Board of Veterinary Examiners (KBVE) is pleased to offer the opportunity to new graduates with a Doctor of Veterinary Medicine (DVM or VMD) to become licensed in the Commonwealth of Kentucky on the day of graduation from an AVMA COE accredited program. In order to participate in the New Graduate Licensure Program, students shall comply with the following requirements:

- Have a current **Application for Licensure as a Veterinarian** on file with the KBVE no later than 30 days in advance of the date of graduation. This includes:
  - ✓ Paper Application;
  - ✓ \$450 Fee (total for both application and exam fees);
  - ✓ State Exam Answer Sheet (with a passing score of at least 80%);
  - ✓ Color portrait image;
  - ✓ Verification of Good Standing from the accredited college of veterinary medicine (CVM);
  - ✓ AAVSB VAULT Report or ICVA Score Report showing passing NAVLE score;
  - ✓ Any court documents or disciplinary records related to convictions other than minor traffic violations and as required by the Application for Licensure as a Veterinarian; and
  - ✓ The results of an FBI fingerprinted background check;
- Have signed this Agreement Form and submitted to Vet@ky.gov; and
- Promised to submit a copy of the CVM diploma or an official copy of the final transcripts within 90 days of licensure. Graduates may comply with this requirement on the day of graduation by emailing a picture or digital copy of the diploma received. Email official documents to <a href="Vet@kv.gov">Vet@kv.gov</a>.
