CALL TO ORDER

Perry Wornall, D.V.M., Chair, called the meeting to order at 12:15 p.m.

MINUTES

A motion was made by Eric Peterson, D.V.M. to approve the minutes of the December 4, 2014 meeting. Motion, seconded by Dr. Eckert, carried.

MONTHLY FINANCIAL REPORT

A financial statement for the month ending December 31, 2014 was presented to the Board for review. A motion was made by Dr. Eckert to approve the financial reports as presented. Motion, seconded by Dr. Peterson, carried.

O&P REPORT

The board was presented with an O&P report from Gordon Slone, Executive Director. No further action was required.

LICENSURE STATUS REPORT

A Licensure Status Report dated January 27, 2015 was presented to the Board for review. The report showed there are currently 2,219 active licensed veterinarians along with 254 active licensed veterinarian technicians. The report also indicated 62 licensed animal control shelters and 186 licensed euthanasia specialists. No further action was required.

A motion was made by Dr. Wills to ratify approved Veterinary, Veterinary Technician, and Euthanasia Specialist licenses issued from December 3, 2014 to January 27, 2015 by the applications committee. Motion, seconded by Gene Smith, D.V.M., carried.

NEW BUSINESS

Jim Weber Chairman of the KVMA Legislative Committee spoke with the board about changes to the Practice Act to be introduced in the 2016 legislation.

After speaking with Dr. Weber, the board asked legal counsel to look into the following three (3) things:

- (I) Can a veterinarian turn down prescriptions if requested to write one by a client
- (II) Can a veterinarian report animal abuse/cruelty or does that violate a client's privacy
- (III) Is a veterinarian required by law to report a felony or suspected felony

The board reviewed correspondence from Jessica Hicks regarding telemedicine. A motion was made by Dr. Vaughn to inform Ms. Hicks that petzam.com, an internet vet service, did not provide a valid client patient relationship. Motion, seconded by Dr. Smith, carried.

The board briefly discussed issues regarding spay and neuter clinics, equine dentistry, and veterinary hospitals. The board agreed these issues and some others should be spelled out in the board's standard of care in the law in the future. The Board discussed the possibility on educating the public on the standards of care in the KVMA newsletter as what the board sees as the definition of standard of care. No further action was required.

Loran Wagoner, D.V.M., Board Investigator reported on the January 2015 Keeneland Sale Report. No further action was required.
