## **COMPLAINTS COMMITTEE**

A meeting of the Kentucky Board of Veterinary Examiners, Complaints Committee, was called to order at 10:30 a.m. Motion was made by Steven J. Eric Peterson, D.V.M., Vice Chair, called the meeting to order at 12:34 p.m.

#### MONTHLY FINANCIAL REPORT

Financial statements for the months ending January 31, 2015 and February 28, 2015 were presented to the Board for review. A motion was made by Dr. Eckert to approve the financial reports as presented. Motion, seconded by Dr. Wills, carried.

#### **O&P REPORT**

The board was presented with an O&P report from Gordon Slone, Executive Director. No further action was required.

### LICENSURE STATUS REPORT

A Licensure Status Report dated March 16, 2015 was presented to the Board for review. The report showed there are currently 2,230 active licensed veterinarians along with 263 active

licensed veterinarian technicians. The report also indicated 61 licensed animal control shelters and 192 licensed euthanasia specialists. No further action was required.

A motion was made by Dr. Wills to ratify approved Veterinary, Veterinary Technician, and Euthanasia Specialist licenses issued from January 28, 2015 to March 16, 2015 by the applications committee. Motion, seconded by Gene Smith, D.V.M., carried.

#### **NEW BUSINESS**

The board reviewed correspondence from Derrick W. Graham, State Representative regarding the number of online credit hours allowed for continuing education by the Board. After reviewing the correspondence Dr. Wills recommended changing the regulations to reflect an increase in online continuing education veterinarians are allowed to obtain. The Board attorney said he could draft a proposal in the future to get this changed in the regulations. Dr. Smith said he would research some other states and see what they do and report back to the Board at the next meeting. No further action was required.

The Board reviewed correspondence from NBVME regarding NAVLE enhancements. No further action was required.

The Board reviewed correspondence from NBVME regarding 2015-2018 Administrative Agreement. No further action was required.

The Board reviewed correspondence from the Courier Journal regarding use of private email and texting. Marcus Jones, Board Attorney briefly commented on the article. No further action was required.

The Board reviewed correspondence from Stacy L. Vanhorn, D.V.M. No further action was required.

The Board reviewed correspondence from Mary Scollay, D.V.M. from the KY Horse Racing Commission regarding a letter she received from PETA informing her about the treatment of horses on the racetrack with the use of a thyroid supplement. Dr. Peterson briefly commented on. No further action was required.

### LEGAL COUNSEL

Marcus Jones introduced himself to the Board as the new Board Attorney. Mr. Jones discussed an issue that came up at the last meeting regarding reporting animal abuse and said a vet could advise a client to stop abusing their animal if they suspected an animal was being abused. If the client does not stop the animal abuse then the client-patient relationship could be terminated. Once the client-patient relationship is terminated the veterinarian could report the abuse to animal control or the police. Mr. Jones said he would provide this information to KVMA. No further action was required.

Mr. Jones also addressed the board about their question if a vet could turn down prescriptions if requested to write one by a client. After reviewing the laws and regulations Mr. Jones was of the opinion a veterinarian would be required to write the prescription.

Mr. Jones further addressed the Board regarding correspondence from a Debbie Metcalf with Stolen Horse International who asked if one could have a business that injects GPS trackers into animals. Mr. Jones stated one could inject their own animals, but you could not have a business and inject other people's animals. Either the owner or a veterinarian would have to inject the GPS tracker. Mr. Jones did say one could have a business that sold the GPS trackers to the owner, but that was all they could do.
