COMPLAINTS COMMITTEE

A meeting of the Kentucky Board of Veterinary Examiners, Complaints Committee, was called to order at 10:30 a.m. Motion was made by Eric Peterson, D.V.M., to go into closed session per KRS 61.810(1) (c) and (j), motion carried. Dr. Peterson, D.V.M., Vice Chair, called the meeting to order at 12:18 p.m.

MONTHLY FINANCIAL REPORT

Financial statements for the months ending March 31, 2015 and April 30, 2015 were presented to the Board for review. A motion was made by Steven Wills, D.V.M. to approve the financial reports as presented. Motion, seconded by Sam Vaughn, D.V.M., carried.

O&P REPORT

Gordon Slone, Executive Director briefly discussed the new on-line renewal system and One-Stop registration troubles the Board experienced last Fall with their renewals and improvements that have been made since. No further action was required.

Mr. Slone informed the Board they had a new phone number due to a new phone system that was installed. No further action was required.

Mr. Slone presented the Board with a Memorandum of Agreement (MOA) between the Office of Occupations and Professions and the Kentucky Board of Veterinary Examiners. Mr. Slone reported that everything was the same except some language about federal anti-discrimination language. After review and discussion Dr. Wills made a motion to approve the MOA. Motion, seconded by Dr. Van Balen, carried.

LICENSURE STATUS REPORT

A Licensure Status Report dated May 27, 2015 was presented to the Board for review. The report showed there are currently 2,275 active licensed veterinarians along with 282 active licensed veterinarian technicians. The report also indicated 61 licensed animal control shelters and 197 licensed euthanasia specialists. No further action was required.

A motion was made by Dr. Wills to ratify approved Veterinary, Veterinary Technician, and Euthanasia Specialist licenses issued from March 17, 2015 to May 27, 2015 by the applications committee. Motion, seconded by Dr. Van Balen, carried.

NEW BUSINESS

The Board reviewed correspondence from AAVSB regarding call for nominations for upcoming positions. No further action was required.

The Board reviewed correspondence from AAVSB regarding recommendations on proposed bylaws amendments. No further action was required.

The Board reviewed correspondence from Logan Walker regarding mobile spay and neuter clinics. After review and discussion the board agreed to table the matter for further review.

The Board reviewed correspondence from Donna Fetters, LVT regarding veterinary hospital laws for wildlife. Her main question was whether veterinary hospitals could treat and/or euthanize wildlife brought in by animal control. After review and discussion the board asked legal counsel to prepare a letter with their response.

The Board reviewed correspondence from Amy Cooper regarding euthanasia. Marcus Jones informed the Board he had already responded to Ms. Cooper in an email.

The Board reviewed correspondence from Melina Rodriguez regarding canine rehabilitation and massage. After review and discussion the Board agreed one must be employed and under the direct supervision of a licensed Kentucky veterinarian in order to perform canine rehabilitation and massage. The Board requested legal counsel to respond. No further action was required.

The Board reviewed correspondence from Nancy Brennan, D.V.M. regarding her reinstatement application. After review and discussion a motion was made by Dr. Wills to deny waiver the of reinstatement fee. Motion, seconded by Dr. Vaughn, carried.

Mr. Jones shared two legal opinions with the Board regarding reporting animal abuse by a veterinarian and writing prescriptions in response to questions received by the Kentucky Veterinary Medical Association. No further action was required.
