# LICENSURE STATUS REPORT

A Licensure Status Report dated January 26, 2016 was presented to the Board for review. The report showed there are currently 2,399 active licensed veterinarians along with 317

active licensed veterinarian technicians. The report also indicated 59 licensed animal control shelters and 199 licensed euthanasia specialists. No further action was required.

Dr. Wornall explained that once the board receives a complaint it is sent out for a response from the licensee. Once the response is received by the board, the complaint and response are sent to the complaint committee for review. There the complaint is either dismissed or sent off for and investigation. Dr. Wornall explained the process can be long, especially if it goes further than the investigative stage. No further action was required.
