#### PROCEEDINGS

Committee Chair Dr. Dawes called the meeting to order at 2:03 pm EST.

Members requested that Committee Chair Dr. Dawes continue giving the in-depth backgrounds that she has been providing.

Members of the Committee reconciled their case notes and agreed to report the following updated case statuses and recommendations to the full Board during the March 26 Board meeting.


