BUSINESS AGENDA

GUEST SPEAKERS

• Mr. Eric J. Hamelback, CEO, The National Horsemen's Benevolent and Protective Association (HBPA) – Presentation on the Horseracing Integrity and Safety Act (HISA)

Highlights of presentation:

- HISA is tntended to create uniform, national rules and regulations, subject to FTC approval, that keep horses and jockeys safe
- Signed into law by President Trump. Enacted in December 2020. Some parts already in effect general effective date is July 1, 2022
- Two lawsuits in progress challenging the constitutionality of the law, one each in the Fifth Sixth Circuit Courts
- The Governing Authority is a private entity
- HISA includes reporting requirements for all veterinarians, even if they are not licensed by the Racing Commission. Medical records for all "covered horses" from any veterinarian must be submitted to the Governing Authority. Methods of submission and technological considerations have not yet been defined
- Reporting requirements likely to be burdensome for ambulatory or mixed practitioners
- o There will be difficulties for veterinarians in knowing which horses are covered
- o In many ways, HISA duplicates duties and paperwork of state racing commissions
- o Enforcement against violations detailed on website
- Three (3) sets of regulations already passed:
 - Safety
 - Assessment and methodology, and
 - Penalties and procedures
- o FTC will review a final set of anti-doping regulations; supposed to be submitted July 1
- Only three (3) jurisdictions currently agree to participate with the allocation process California, Kentucky, and Minnesota. Virginia likely will, but has not yet committed
- Kentucky assessed a \$1.3 million dollar liability to participate, and there has been no transparent discussion about how those funds will be generated
- o Non-Thoroughbred racing is not currently covered

A MOTION was made by Dr. Eckert to approve all allowable costs associated with travel for KBVE Investigator Dr. Coy St. Clair to attend the Medical Records Training being hosted by the West Virginia Board of Veterinary Medicine. The motion, seconded by Dr. Gardner, passed unanimously.

• RFP for Investigative Services

A new RFP for Investigative Services was released on May 26. Ms. Shane will send out an email blast to all licensees alerting them to this opportunity.

OLD BUSINESS

• AAVSB Updates

- AAVSB has distributed proposed Bylaw Amendments, as submitted from the California Veterinary Medical Board. Members of the Board will need to vote and direct the Kentucky Delegate to AAVSB to represent this vote at the 2022 Annual Meeting. The board will vote on this at July meeting.
- Ms. Shane has been invited to speak at the AAVSB Annual Meeting. She will co-present with representatives from Arizona, Ohio, and Alberta at a session called 'Facility Standards and Permitting'.

• OSV Partnership Meeting

- Dr. Gardner, Dr. Park, and Ms. Shane met with Dr. Katie Flynn, Kentucky State Veterinarian on May 12.
- Ways KBVE can support / assist OSV
 - Provide USDA APHIS Accreditation information for all KBVE licensees, biennially



- Provide current mailing addresses for all KBVE licensees, upon request
- Provide Licensee Demographics Reporting, upon request (max of twice per year)
- Provide email blast communications re disease outbreaks and other alerts to licensee population
- Increase messaging on website to support reporting to OSV (i.e., Reportable Diseases)
- KBVE may consider revisiting the Personnel Classifications for veterinarians and make new salary recommendations to the Personnel Cabinet
- KBVE and OSV may coordinate outreach to the County Judge/Executives on ACAs/AESs, CS responsibility, and reporting of animal abuse
- Other points of discussion:
 - USDA APHIS
 - At this time, USDA states that blood draws for Coggins must be completed by an accredited veterinarian
 - May engage with USAHA and NVAP to see if there is any room for movement in regulatory requirements re allowing LVTs to assist in some work
 - College of Veterinary Medicine (CVM) screening criteria & VMCAS
 - Auburn CVM Dr. Melinda Camus and Mr. Glenn Sellers program engaging veterinarian students with rural practices
- Request to Kentucky County Judge/Executive Association (KCJEA) and Kentucky Magistrates & Commissioners Association (KMCA) joint meeting in June update In the event KBVE is not able to speak to this group, Members of the Board directed Ms. Shane to pull together draft letters to be sent to these organizations and also directly to County Judge/Executives. The letters should include reminders of responsibilities related to controlled substance management and the rules for KBVE-certified animal control agencies and limitations on animal euthanasia specialist scope of practice. Additionally, Ms. Shane should coordinate with OSV re animal abuse responsibilities.
- Puerto Rico Board of Examiners of Veterinary Medicine Request for Reciprocity Members of the Board reviewed the reciprocity request from the Puerto Rico Board of Examiners of Veterinary Medicine. Mr. Bilby advised that the board had no authority to offer a reciprocity agreement. Mr. Brengelman pointed out that the KBVE statutes allow for licensure by endorsement. Chairman Wills directed Ms. Shane to respond to Puerto Rico accordingly.
- KBOP info re anonymous prescription complaints

At the Practice Act Modernization regional stakeholder meetings, KBVE received a substantial amount of feedback and complaints about the aggressive tactics of the online veterinary pharmacies, however no one has followed up with details yet that can be sent to KBOP



APPLICATIONS COMMITTEE REPORT

Dr. Gardner and Dr. Smith provided an update from the Applications Committee.

- New Graduate Licensure Program in 2022:
 - LMU Graduates new to program this year 13 new graduates
 - Auburn Graduates one additional Auburn grad, for a total of 23 new graduates
 - Total of 36 new graduates eligible to participate in the New Graduate Licensure Program, all licensed and ready to work in Kentucky on graduation day

• Veterinary Specialists

<u>201 KAR 16:500, Section 5</u> states "A veterinarian shall not represent to the public that he or she is a board certified specialist in any specialty of veterinary medicine unless that veterinarian has been certified by an entity approved by the American Veterinary Medical Association (AVMA) and has submitted the certification for filing with the board."

Members of the Board discussed veterinary specialists, related terms, what constitutes proof for identification of specialists, and how the board may best track this designation in the KBVE database and during renewal.

• ACAs that expired, and how many AES moved to inactive

Ms. Shane provided an update following the closure of the renewal and grace period for KBVE-certified animal control agencies (ACA) and animal euthanasia specialists (AES).

 - 1 shelter manager moved to inactive,
 - 2 pending applications
- Union County status unknown closeout inspection needed
 - No listed AES

WELLNESS COMMITTEE REPORT

EDUCATION AND OUTREACH COMMITTEE

- KVMA E&O contract schedule
 - Sun, June 5 Buffalo Trace Meeting
 - o Members of the Board discussed possible topics to cover in KBVE presentation
- Kentucky Animal Care & Control Association (KACCA) Annual Conference September 21-23, Louisville, KY
 - Ms. Shane was invited to speak on September 21 and will cover certification requirements, issues in shelters, Controlled Substance Management, etc.
 - 0 Ms. Shane asked that the board consider sending KBVE Investigators to this meeting



GOVERNMENT AFFAIRS COMMITTEE

- KBVE Policy 2104 Appropriate Use of Anesthesia Drugs in Small Animal Medicine
 - Adopted by KBVE on 9/23/2021, the policy stated that the KBVE felt the use of Telazol or Rompun/Xylazine as an anesthetic protocol was no longer consistent with standards of care for small animals due to the potential dangerous effects these drugs have on the health of patients.
 - A Kentucky veterinarian sent the policy out on the Veterinary Information Network (VIN) which caused a flood of calls and written communication to the KBVE office, including outreach from the American Veterinary Medical Association (AVMA) and the American College of Veterinary Anesthesia and Analgesia (ACVAA).
 - KVMA also discussed this issue at their May 19 board meeting, and asked for clarification from KBVE if the policy was meant to state "sole anesthetic protocol".
 - Many comments were alarmed that Telazol was listed, as no one felt this was a bad product

Chairman Wills indicated that in order to provide this issue due diligence, the board should review all comments and conduct further research.

Mr. Brengelman counseled that policy holds no legal weight, and discussed the need to put anything the board wants to enforce in regulation.

A MOTION was made by Dr. Eckert to withdraw KBVE Policy No. 2104 and remove it from the website. The motion, seconded by Dr. Gardner, passed unanimously.

Dr. Smith discussed his personal research on the issue and provided insights on his experiences. He also reached out to anesthesiology contacts at Auburn and UT who agreed that Xylazine is not recommended as part of a small animal anesthesia protocol. There are safer, more modern options are available, but they are often not the most cost effective. He relayed that Xylazine is generally used in low-cost scenarios that are likely to have limited access to warming, blood pressure support, resuscitation, etc. which combine to put these animals at risk long term.

Ms. Shane requested Chairman Wills form a working group to explore this issue further with stakeholders, and present recommendations to the board. Stakeholder discussion group volunteers:

- o Dr. Smith
- o Dr. Dawes
- o Dr. Wills

Dr. Ashley Morgan from AVMA commented that the national organization is willing to participate and engage with comments in the stakeholder meeting. She also let the board know that Dr. Golab has comments on the KBVE website statement on industrial hemp / cannabis, and will coordinate with Ms. Shane to provide information to the board on this topic for future discussion.



• Practice Act Modernization Proposal – updates

- Kentucky HSUS, HSUS, and HSVMA update
 - Chairman Wills, Dr. Park, Dr. Dawes, and Ms. Shane met with representatives of these organizations,
 - Todd Blevins, State Director, Kentucky Humane Society of the United States (HSUS)
 - Jessica Simpson, HSUS (national office) Policy Analyst focus on companion animal
 - Pam Runquist, E.D., Humane Society Veterinary Medical Association (HSVMA) vet affiliate of HSUS – focus on companion animal
 - These organizations focused their points of discussion:
 - Wish to lift all in-person requirements for VCPR
 - Seek to extend prescription requirements to 18 months
 - State they want to provide for rural area needs
 - State they want veterinarians to "use [telehealth] at their discretion" and be able to make an in-person requirement decision on their own
 - Cite AAVSB provisions outlining "safeguards" to ensure protections for animals when there are no in-person requirements

o KBVE-KVMA Joint Stakeholder Meetings

- Eight (8) meetings completed; two (2) remain
- Average of 35 attendees per meeting
- KVMA and the local VMAs have provided tremendous support, including securing venues and proving meals at each event
- Attendees seem to leave the meetings with a better understanding of need for facilities registration
- Multiple stakeholders would like to see the board publish more statistics in various complaint areas
- Stakeholder feedback binder in board packet for review includes notes from meetings, as well as written comments submitted to the board

LRC – Joint Interim Committee on Licensing, Occupations, & Administrative Regulations (L&O)

• KBVE is likely to appear on an agenda this summer

Pause on resending to Ag leadership until following June 15 meeting and an updated bill from LRC is in hand.



• KDA Stakeholder's Dialogue on the status of Large Animal Veterinarians

Keith Rogers, COS, KDA Chief of Staff provided an update

- Seeking to coordinate dialogue between the veterinary industry and agriculture regarding food animal veterinarian shortage
- Scheduled for June 15 @ 10 am at the KSU Research Farm
- All Kentucky agricultural and commodity groups have been invited to participate
- Presenters to include leads from the veterinary community, including OSV, KVMA, KBVE, Auburn University CVM
- Auburn CVM participation:
 - Dean Calvin Johnson, DVM
 - Melinda Camus, DVM, Associate Dean for Academic Affairs
 - Glen Sellers, MBA, MS, Clinical Lecturer, Coordinator of Practice Management and the lead faculty member for a USDA grant to train, recruit, and support veterinarians in underserved regions of Kentucky
- o KBVE will present licensing demographics and Practice Act updates
- Animal Control Advisory Board (ACAB) proposed meeting update
 - Pending later this summer
- Policy Discussion Tele-triage services and after-hours care -
 - Guardian Triage / afterhours services. Chairman Wills made contact and provided an update to the board.
 - Entirely teletriage does not diagnose, refers to emergency care if needed.
 - Many operators are LVTs.
 - Has the appearance of professional advice
 - Questions from the board:
 - Who is responsible if a client is told a situation is not an emergency and there is a bad outcome?
 - Is the veterinarian / the practice who contracts with Guardian held accountable?
 - If a corporate owned facility contracts with an afterhours service such as Guardian to offer triage service, and the employee veterinarian has no choice in that, who is responsible?
 - Mr. Brengelman encouraged the board to incorporate these questions and answers in a newsletter or similar to licensees
 - KVMA offered space in their newsletter
